Conditions of Machinery Use:

- 1) Machinery operators must provide a copy of their Driver's License to be on file at the Fairgrounds Office.
- 2) The machinery settings are to be maintained as approved by the Fairgrounds staff and according to Fairgrounds specifications.
- 3) The machinery will have a full fuel tank to start the event. No fluids are to be added.
- 4) In the event the machinery fails to operate properly, the machinery operator is not authorized to make repairs and must contact the Fairgrounds staff.
- 5) The machinery operator is responsible for any damages incurred to machinery or property while in use at the Fairgrounds.
- 6) Only an approved machinery operator (listed above) will operate the equipment.
- 7) Only the approved machinery operator may be in/on the machinery during the event.
- 8) No animals or children are allowed on/in the machinery.

- 9) The User will be invoiced for fuel usage during the event, after the tank is refueled by Fairgrounds staff at a cost of \$5/gallon.
- 10) The User will be invoiced for engine hour usage on each machine during the event at a rate of \$15/engine hour.
- 11) The machinery operator agrees to not use intoxicating substances or alcohol before or during the operation of Fairgrounds machinery.
- 12) The machinery operator will not use a cell phone or distracting devices while operating Fairgrounds machinery.
- 13) The key to the Fairgrounds machinery <u>must</u> be returned to the Fairgrounds Office or deposited into the Deposit Box located at the Fairgrounds Office at the end of the event.
- 14) The Fairgrounds machinery will be parked at a location determined by the Fairgrounds staff at the conclusion of the event.
- 15) The Fairgrounds machinery check out/in sheet must be completed before and after each event.
